Applicant, Guarantors, and Blue Streak agree that any disputes or legal action arising between them for services provided to Applicant and Applicant's failure to pay any amounts owed to Blue Streak shall be submitted to a court of proper jurisdiction located in Midland County, Texas, where venue shall lie. Applicant guarantees the payment of all amounts owing from Customer to Blue Streak Transportation, including costs of collection and attorney's fees where applicable. It is further expressly agreed and stipulated that all questions concerning the validity, interpretation, or performance of any of the terms or provisions of this Application/Agreement, or any rights or obligations of the parties hereto, shall be governed by and resolved in accordance with the laws of the State of Texas.

Equipment Lease Agreement: Customer assumes all liability arising from or pertaining to its possession, operation, use, maintenance, repair, and storage of the equipment. Customer also assumes and shall bear all liability of loss or damage to, or theft or destruction of the equipment. No repairs, adjustments, or replacements of any parts or accessories to the equipment will be made without Blue Streak Transportation's prior written permission. Customer shall cause the equipment to be used and operated in accordance with all applicable manufacturer's manuals and instructions, and in accordance with all government laws and regulations.
